1. OBJECT OF THE BID

- 1.1 This bid refers to the CONCESSION for the regionalized provision of public water supply and sanitary sewage services for Block [•], in the State of Rio de Janeiro.
- 1.2 In addition to the present bid, the Bidder presents, in this bidding process, a BID for the Block (s) [•].

2. FIXED CONCESSION FEE

- The BIDDER proposes the total amount of R\$ $[\bullet]$ ($[\bullet]$) as FIXED CONCESSION FEE, having as base date the date of delivery of the bid.
- 2.2 The proposed value represents the minimum price established for the Block $[\bullet]$, plus the offered difference of R\$ $[\bullet]$ ($[\bullet]$), in relation to the minimum price and shall be paid as set forth in the ITB.
- 2.3 For the purpose of judging the bids, the minimum price established for Block [•], corresponding to R\$[•] ([•]), will be monetarily updated for the first day of the month of the delivery of the BID, with the application of the CPI Consumer Price Index of FIPE Fundação Instituto de Pesquisas Econômicas.
 - 2.3.1 In the event that the index pertaining to the month of delivery of the bids has not been released by the date of delivery of the bids, the update shall be calculated with the application of the last known monthly variation of the index.

2.4 This BID is irrevocable, irreversible and unconditional.

3. OBLIGATIONS

3.1 The BIDDER undertakes the obligation to pay the amount of 0.5% (half percent) of the sum of the revenues of the tariffs billed monthly, for the performance of the activities of regulation and supervision of the AGREEMENT, which shall be transferred to the REGULATORY AGENCY.

3.2 The BIDDER undertakes the obligation to pay the amount of 3% (one percent) of the TARIFF REVENUE collected from the municipal area served, for each respective municipality, as VARIABLE CONCESSION FEE;

3.3 The BIDDER undertakes the obligation to pay the amount of 0.5% (half percent) of the TARIFF REVENUE collected from the municipal area served, related to the METROPOLITAN REGION, as VARIABLE CONCESSION FEE to the Metropolitan Region Development Fund;

3.4 The BIDDER undertakes to take all necessary and sufficient measures for the satisfactory provision of the SERVICES, as established in the ITB and its annexes, as well as to bear all costs, burdens, expenses and pecuniary obligations arising from the provision of the services.

3.5. The BIDDER is fully aware of the nature and extent of the risks assumed and has taken into account the risks provided for in the draft CONCESSION AGREEMENT when preparing the bid.

4. BID VALIDITY

4.1. This bid shall be valid for 180 (one hundred and eighty) days, as from the date of the bid opening session and, for this period, all conditions shall be maintained.
